OLOIKA IS LOCATED IN THE GREAT RIFT VALLEY REGION OF SOUTHERN KENYA, AN AREA THAT IS EXPERIENCING FAMINE DUE TO A DECADE-LONG DROUGHT IN THE REGION. THIS MONEY WAS USED TO BUILD A 2,200 SQUARE-FOOT SCHOOL BUILDING MADE OF COMPRESSED EARTH BLOCKS, WHICH ARE BRICKS MADE FROM CEMENT AND LOCAL EARTH.
